Every Secretary of State fee for forming and keeping an Ohio LLC, checked against the official fee schedule, Form 610, ORC 111.16, and Ohio Department of Taxation pages, with fill-in lines for your own total

The recurring calendar (year two onward)

- Secretary of State: nothing. Ohio LLCs file no annual or biennial report and pay no report fee.
- Statutory agent: keep an Ohio street address on file (no P.O. box, no CMRA private mailbox). A change costs \$25 with Form 521.
- Municipal net profit tax: a local income tax on business net profit, set by your city. It can be filed with the city or, by opting in under ORC 718.80, through the Ohio Business Gateway.
- Commercial Activity Tax: \$0 at or below \$6 million in Ohio taxable gross receipts (tax years 2025 and later). Above it, 0.26%; register within 30 days of crossing the line. The old \$150,000 threshold and Annual Minimum Tax no longer apply.
